Ten discreet confirmation soil samples were collected on 9/12/18 (4 wall and 1 base) from each produced water tank excavation and analyzed for benzene, toluene, ethylbenzene, total xylenes (BTEX), gasoline range organics (GRO), and diesel range organics (DRO). Concentrations of BTEX, GRO, and DRO were not detected at or above laboratory reporting limits in any of the samples. See the attached laboratory report, soil analytical table, and Figure 3.
