The leak was repaired and the impacted soil was removed. The remaining soil was tilled and treated in place.

PROPOSED SAMPLING PLAN

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Under the prior operator, Bonanza Creek, three initial soil sample analytical results came back above COGCC Table 910-1 concentration levels for inorganics. The soil was treated in place and resampled a year later. The subsequent analytical results indicate continued exceedence of COGCC Table 910-1 standards for inorganics. KPK has been operating the facility since the spring of 2018 and has continued tilling/discing the impacted. Soil samples will be collected in the Fall of 2018 to track progress of natural attenuation and to determine if concentrations are compliant with COGCC Table 910-1 levels.
