Summary of work to be completed:

1. TOH with rods, pump & tubing.
2. Dump 2 sks. Cement on top of CIBP at 5250' to abandon the Spergen.
3. Perforate Marmaton at 4468'-4502'.
4. Run packer and tubing.
5. Set packer at ~4450'.
6. Anticipate acidizing with 500 gals. 15% MCA and 1500 gals. 15% NE acid.
7. Swab down and flow test.
8. Put well back on production with Lansing perms shut-in behind tubing and packer.
9. Plan to commingle Lansing and Marmaton production in the future after the Marmaton has depleted to the point that it does not flow.
