Summary of work to be completed:

1. TOH with rods, pump & tubing.
2. Perforate the Fort Scott at 4580'-82' and the Marmaton at 4558-62'.
3. Run RBP, packer and tubing.
4. Set RBP at ~4600' and packer at ~4570'.
5. Acidize the Fort Scott with 300 gals. 15% MCA.
6. Swab test the Fort Scott.
7. Move RBP to ~4570' and packer to ~4500'.
8. Swab test the Marmaton,
9. Anticipate acidizing with 500 gals. 15% MCA and 1500 gals. 15% NE acid.
10. Swab down and swab test.
11. TOH with tubing, packer and RBP.
12. Run tubing, pump & rods.
13. Put well back on production commingling Marmaton and Fort Scott.
