The Conrad 1-6 pit was permitted to be used as an earthen pit in 1980 (Pet ID #118857). The size of the pit was constructed to be 2 feet, 8inches wide by 2 feet 8 inches long and 3 feet deep. Since that time this pit has been covered and is no longer in use. The location is and has been used as native grass pasture used for grazing cattle since that date. Reclamation appears to be complete and no further remediation is needed. Please see the attached pictures. Despite multiple requests we have not been able to obtain a signed surface use agreement from the surface owner.
