Anadarko Petroleum Corporation. (Anadarko) requested a rangeland description and pictures for the Reese 22-21HZ Pad. Please let me know if you require further information.

Plant Communities

There is one plant community associated with the disturbance area for the proposed Reese 22-21HZ Pad. The vegetation community consists of a disturbed fallow rangeland area dominated by weedy, upland forb and grass species.

Current Land Use

Fallow rangeland adjacent to abandoned poultry farm (100%)

Noxious Weeds

Scotch thistle - *Onopordum acanthium* (List B)

Cheatgrass - *Bromus tectorum* (List C)

Field bindweed - *Convolvulus arvensis* (List C)

Dominant Rangeland Species

Russian thistle (*Salsola kali*), netseed lambsquarters (*Chenopodium berlandieri*), western wheatgrass (*Pascopyrum smithii*), scotch thistle (*Onopordum acanthium*) – (List B noxious), cheatgrass (*Bromus tectorum*) - (List C noxious), field bindweed (*Convolvulus arvensis*) - (List C noxious), common sunflower (*Helianthus annuus*), crested pricklypoppy (*Argemone polyanthemos*), crested wheatgrass (*Agropyron cristatum*), horseweed (*Conyza canadensis*), Rocky Mountain Bee Plant (*Cleome serrulata*), curlycup gumweed (*Grindelia squarrosa*), and yellow salsify (*Tragopogon dubius*)
