List B Colorado Noxious weeds, Canada thistle and Musk thistle, were observed at the well location. Also, subsidence was observed.

Access road will remain IN-PROCESS as vegetative standards are not reflective of reference area levels. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including weed management.

Corrective Action:

**Corrective Action (CA) #1: Properly remove and control all noxious weeds by 10/19/2018.**

**CA #2: Correct subsidence and reseed using a seed mixture requested by the surface owner or a mixture prescribed by the local county NRCS by 11/16/2018. Additional topsoil shall be added to the depression and the land shall be re-leveled as close to its original contour as practicable. Replacement topsoil shall be from a source that does not have weed infestation of any kind. The replacement soil should be of the same quality to the reference topsoil.**
