Plug set down hole for offset PDC Josephine frac at 6576'. Casing was pressure tested up to 2000' and a 5K wellhead was installed at surface all valves are cshut. The two sacks of cement placed on top of the CIBP technically designates this formation as AB, however, the TA distinction was chosen because PDC intends to return this well to production upon the conclusion of the frac.
