4. TIH with CIBP. Set BP at 6574'. Top with 2 sxs 15.8#/gal CI G cement.
5. TIH with CIBP. Set BP at 6320'. Top with 2 sxs 15.8#/gal CI G cement.
6. TIH with casing cutter. Cut 4 1/2" casing at 1500'. Pull cut casing.
7. TIH with tubing to 1615'. RU cementing company. Mix and pump 1165 sxs 15.8#/gal CI G cement down tubing (Pierre coverage from 1615'-1200'). Cement should circulate to surface.
8. Cut surface casing 6' below ground level and weld on cap.
