Comment:

Inspection doc. #682401035, #682502076, #682502603 and 682502803 required operator to perform reclamation at the well and former battery location. Unable to find evidence that reclamation activities have been conducted per the corrective actions; well location remains bare and exposed soil or predominantly undesirable weedy plant species. Adjacent reference for well appears to be perennial salt grass. Fence remains at battery location, adjacent reference for battery appears to be cropland; battery has not been returned to cropland and no 502.b SOVR to waive reclamation has been submitted/approved. This is the 5th inspection requiring reclamation work to be conducted. Original corrective action and corrective action dates remain applicable.

Corrective Action:

Perform reclamation in accordance to COGCC 1004 series reclamation rules and requirements. CA date of 8/24/2016 remains in place.
