Comment: Location does not meet Final Reclamation requirements. The entire location including the well pad & access road, are not re-contoured, de-compacted, or revegetated. Reclamation activities were to be complete one year after Plugging of Well which would have been 10/10/15. Site has been Out of Compliance for three Years. Weeds, Halogeton & Russian thistle are established on site. Equipment noted in Previous Insp has been removed. Refer to Photo Log attached.

Corrective Action:	Perform final reclamation on the access road and location per COGCC 1004 Rules including but not limited to recontouring, replacement of topsoil, and seeding of site. Install and maintain appropriate BMPs to stabilize location until uniform vegetation establishes across all disturbance areas. All reclamation activities to be complete by November 30, 2018.
