Comments Well is part of the 14-well AE32-05 Multi (Doc #401636962), consisting of the seven (7) existing Wells Ranch AE32-670 (API: 05-123-41722), Wells Ranch AE32-635 (API: 05-123-41725), Wells Ranch AE32-665 (API: 05-123-41726), Wells Ranch AE32-640 (API: 05-123-41727), Wells Ranch AE32-645 (API: 05-123-41728), Wells Ranch AE32-650 (API: 05-123-41729), Wells Ranch AE32-655 (API: 05-123-41730); the seven (7) proposed Wells Ranch State AA36-622 (Doc #401637106), Wells Ranch State AA36-633 (Doc #401637067), Wells Ranch State AA36-643 (Doc #401637050), Wells Ranch State AA36-654 (Doc #401637033), Wells Ranch State AA36-664 (Doc #401637008), Wells Ranch State AA36-673 (Doc #401636997), Wells Ranch State AA36-683 - Ref. Well (Doc #401636981); with the production facilities within the disturbance. Noble Energy shall isolate both the Fox Hills and Upper Pierre Aquifers with surface casing from hydrocarbon bearing zones and exposure to oil based drilling fluid. Noble Energy also agrees to not expose the UPAq to oil based mud.

	1) Submit Form 42 electronically to COGCC 48 hours prior to MIRU (Spud Notice), for the first well/activity on the pad and provide 48 hour spud notice for all subsequent wells drilled on the pad. 2) Comply with Rule 317.j and provide cement coverage from the end of production casing to a minimum of 200' above Niobrara. Verify coverage with cement bond log. 3) Oil-based drilling fluid is to be used only after all aquifers are covered.

1	Drilling/Completion Operations	Anti-collision: Prior to drilling operations, Operator will perform an anti-collision scan of existing offset wells that have the potential of being within close proximity of the proposed well. This anti-collision scan will include definitive MWD or gyro surveys of the offset wells with included error of uncertainty per survey instrument, and compared against the proposed wellpath with its respective error of uncertainty. If current surveys do not exist for the offset wells, Operator may have gyro surveys conducted to verify bottomhole location. The proposed well will only be drilled if the anti-collision scan results indicate that there is not a risk for collision, or harm to people or the environment. For the proposed well, upon conclusion of drilling operations, an as constructed gyro survey will be submitted to COGCC with the Form 5.
2	Drilling/Completion Operations	During and Post stimulation: Noble Energy will comply with the COGCC Policy for Bradenhead Monitoring During Hydraulic Fracturing Treatments in the Greater Wattenberg Area dated 5/29/12.
3	Drilling/Completion Operations	An existing well on this pad (API #123-30489, Wells Ranch AE 32-05) was logged with open hole Resistivity Log and Gamma Ray Log from the kick-off point into the surface casing. All wells on the pad will have a cement bond log with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall clearly state "No open-hole logs were run" and shall clearly identify (by API#, well name & number) the well in which open hole logs were run.
