PDC requests to add topsoil staging area to this location as shown on the attached Scaled Facility Drawing. The total disturbed acres will be increased to 15.3, with 6.2 acres of that being for topsoil staging. The reclaimed area will decrease slightly to 5.8 acres, where it was previously approved at 6.0. PDC would also like to change the following production equipment: Electric Generator - 1, Blowcase - 1, VRU- 5. All other equipment will remain the same. All cultural distances will remain the same as previously permitted.

3	Interim Reclamation	In accordance with COGCC Rules, the disturbed area will be monitored for noxious weed infestations during all drilling, production and reclamation operations. These areas will be kept free of all undesirable plant species designated to be noxious weeds, as practicable. Weed control measures shall be conducted in compliance with the Colorado Noxious Weed Act, C.R.S. 35-5.5-115 and the current rules pertaining to the administration and enforcement of the Colorado Noxious Weed Act. Weeds will be mowed and sprayed if necessary.
