


# GREELEY-ROTHE 34N-2B-L WELL LOCATION CERTIFICATE - AS-BUILT

  - ALL DISTANCES AND BEARINGS SHOWN HEREON ARE GROUND VALUES AS GPS MEASURED IN THE FIELD, WITH TIES TO WELLS MEASURED PERPENDICULAR TO SECTION LINES.
