Comment: Previous inspections required operator to remove meter shed and related equipment from former battery location per 1004.a. and to conduct reclamation at the well. Operator submitted sundry doc. #401667372 showing equipment is in use. Unable to find evidence that reclamation activities have been conducted per corrective actions; Vegetation at well location is not uniform and remains predominantly undesirable weedy plant species when compared to the reference. This corrective action remains applicable.

Corrective Action:	Perform reclamation at the well location in accordance to COGCC 1000 series rules and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 11/15/2017.	Date	11/15/2017
