Bare soils, rilling, and sediment run-on is occurring in the northeastern project area. Eastern berms not stabilized.</p>						Date: 11/30/2018
<p>Corrective Action: Install stabilization measures including erosion controls, slope stabilization measures, and revegetation in areas with bare and eroding soils identified above. Stabilization measures should function to prevent surface erosion on bare soils, erosional downcutting, and transport of sediment off of the project area.</p>
