Dear Mr. Deranleau & Mr. Louis-Prescott:

This letter provides an update to K.P. Kauffman Company, Inc.'s (KPK) letter dated August 27, 2018, regarding the Sauer Water Well subject to Complaint No. 200446018. As stated and disclosed by KPK in its August 27, 2018 letter, KPK has completed Mechanical Integrity Tests (MIT) and gas sampling of the two KPK operated wells proximate to the above-described Sauer Water Well, the Maul #20-2 (API 123-12420) and the Johnston #20-1 (API 123-12214). The MIT results and the gas analysis results discussed in KPK's August 27, 2018 letter conclude that KPK's proximate oil and gas wells have not contributed to the gas found in the Sauer Water Well.


On September 25, 2018, KPK completed the final testing request from the COGCC for the Sauer Water Well Complaint and ran a temperature and noise log on the Maul #20-2 well. The attached log shows no hydrocarbon migration. Further, the attached COGCC Field Inspection dated September 25, 2018, confirms that there were no anomalies in the temperature log, and that no migration or channeling was detected from the Maul #20-2 well. At the request of Anadarko Petroleum Corporation (APC), KPK plugged and abandoned the Maul #20-2 well on September 26, 2018 following approved plugging orders issued by the COGCC and prior to APC's hydraulic stimulation activities in the area. Further, Anadarko has agreed to take over the water supply to the Sauer family.

Based on the recent testing and the conclusions verified by the COGCC, KPK's proximate Maul and Johnston wells have not contributed to the contamination found by the Sauer's
