Foundation Energy is proposing to add new perfs within the Ft Union sandstone. The well currently produces from the Ft Union and Lewis formations.

Foundation plans to shoot perfs from 4,584' - 4,596' / 4,600' - 4,606' and then frac the interval based on the schedule in the attached procedure.

A pumping unit will be installed if necessary along with another 300 bbl steel oil tank if production volumes warrant.

All fluids will be contained on surface with steel lines and frac tanks.
