Sandy berms in the western and southern project area are not stabilized with vegetation or sufficiently compacted.</p> <p>Corrective Action: Sediment within the project area needs to be better managed. Engineered sediment traps, and frequent maintenance will likely be needed to contain sediment flows and prevent sediment discharge from the project area.
