Thanks for getting back to me. The report isn't very clear, sorry about that!

In October 2014, the final excavated area measured 23 feet by 40 feet by 14 feet deep. Although a soil sample was collected at 9', the excavation continued to a total depth of 14', so that impacted soil sampled at 9' was removed from the excavation.

Attached are 3 open/unresolved spill/release reports for Great Western in Adams county.

The COGCC desires to either close a spill/release within 90 calendar days of initial report, or, if the spill/re/release cannot be closed in that time to a remediation via a Form 27. As of this date these spill(s)/release(s) remains as open issues which have exceeded the 90-day time frame.

To close these spill (NFA determination) GW needs to file supplemental form 19.s with a Request For Closure and supporting documentation. Information is available that would warrant migrating this spill to a remediation (form 27), then GW could accomplish that at any time.
