Noble Energy respectfully request continued TA status. The well is closed to the atmosphere via a RBP bridge plug set at 6308' on 7/20/2016. The well closed to the atmosphere and locked out and tagged out at the master valve. This well was TA'd for an off-set frac, PDC's Loloff Farms 26G-232. Noble will return the well to production once a rig is available - unknown time frame as we are currently working through a large back log of P&A work for offset mitigation work for DJ basin activity. Noble will run an MIT if the well is still TA'd after two years. Form 5A to change the status to TA was submitted on doc # 401114949. The successful MIT was performed on 7/2/2018 and was submitted on doc # 401186458.
