Noble Energy respectfully request continued TA status. The well is closed to the atmosphere via a RBP bridge plug set at 6928' on 12/1/2016 for an off-set frac, specifically for PDC's Schaumberg PAd. Noble will return the well to production once a rig is available - unknown time frame as we are currently working through a large back log of P&A work for offset mitigation work for DJ basin activity. Noble will run an MIT if the well is still TA'd after two years. The successful MIT was performed on 7/21/2018 and was submitted on doc # 401721562.
