Comment:

This location is not in compliance with Rule 1004. Reclamation rules require reclamation activities to be conducted within three months of plugging on cropland. Well was plugged 1/10/2018. Operator has failed to perform final reclamation activities (i.e., remove gravel, decompaction, seedbed prep and seed) at the tank battery location. Please refer to the attached inspection photos for more detail.

The removal of all equipment has been performed at the well and battery location. Well location and well access road will remain in process but additional reclamation activities may be required due to areas not reflective of reference area vegetative levels.

Corrective Action: **Comply with Rule 1004. Corrective action date is being back dated to when all final reclamation activities should have been completed.**
