Comment: COGCC Eng Integrity Inspector met with Top Operating personnel (Jeff Freitas) and witnessed off location and crude oil dump flowline pressure testing. The City of Longmont 1, Sherwood 1 and Sherwood 2 flowlines were pressure tested for approx 30 Minutes; the results of pressure testing for all (3) flowlines are deemed satisfactory (see individual well inspection reports). The (2) crude oil dump flowlines (at the Serafini facility/ battery) servicing all three wells were also pressure tested. The tests recorded minimal pressure deviations (loss < 10%) and adequate stabilization and are deemed passing/ satisfactory per COGCC rule 1104. Top personnel recorded the data on a pressure testing form (document is uploaded to FIR).
