High Bradenhead Pressure During Stimulation Operations:

Two frac crews were being used on the same pad to stimulate these wells. Each frac crew was operating independently of the other. Starting pressure at the beginning of stimulation (10/8 20:43) of the 1Q well using frac crew A was 226psi.

After finishing stage 31 on the 1Q well, frac crew A was rigged down and moved to other wells on the pad. At this point (10/22 05:07), the pressure on the well was 329psi.

Frac crew B then rigged up on the 1Q well. When frac crew B started monitoring the 1Q well bradenhead (10/24 at 07:06), the pressure was 459psi.

Frac on the 1Q well ended 10/27 05:44. At this point, bradenhead pressure was at 625psi.

Since the end of frac on the 1Q well, the bradenhead has been constantly monitored. Pressure has hovered constantly around 625psi with an alarm to go off if pressure exceeds 650psi.

After the frac crews move off the pad, bradenhead pressure will be monitored during drillout and flowback. We will then decide if any further remediation is necessary.
