Based on correspondence from the previous inspection, access is needed for midstream gathering equipment located east, adjacent to the location. When the midstream gathering equipment is no longer needed, Operator shall comply with Rule 1004 to reclaim the access road and any other disturbances, including the remediation project.

Final reclamation activities were conducted previously but failed because of remediation activities per a conversation with the Operator on 11/7/18. Operator has not performed additional final reclamation activities since the previous inspection. Operator shall continue to monitor and manage the Location for erosion and weed control until the location meets Rule 1004 standards.
