A grab soil sample was collected from beneath the vault and submitted for laboratory analysis.

While pulling the vault, groundwater was encountered at a depth of 3.5' bgs. A groundwater sample was collected and submitted for laboratory analysis.

Proposed Surface Water Sampling

Due to the shallow depth to groundwater and its presence in the vault's excavation, a groundwater sample was collected and analyzed for BTEX. The results came back as non-detect indicating the levels were well below the COGCC Table 910-1 concentrations for groundwater.
