The access road not being reclaimed and the incomplete re-contouring are subject of the Variance Request. Noxious weeds appear to have been controlled, though newly emerged Canada thistle rosettes were noted in reclaimed areas, indicating need for ongoing weed monitoring & control Program until site passes Final Reclamation.
