A form 2 was submitted 4/16/18 to recompleat in the Neva zone and we are waiting on COGCC approval. Current wellbore diagram is attached. Proposed well bore diagram with recompletion procedure is attached. The last MIT was 8/16/17. The surface is isolated with a valve and bull plug.
