We would like to include our tank battery inclusively with this 2A for our location on this well. Our production facility already exists (Loc ID NOT YET ASSIGNED) 2A #401826108. We will add 3-400bbl Oil Tanks, 1-400bbl Water tank, 1-Treater 4x20 and an ECD to the current Tank Battery Site and we will hook a flowline from this well to these new tanks on this existing production facility pad if this well is a producer. We will run one 3" poly pipe-pressurized 0-40# PSI and buried at least 4' below the ground surface. These new tanks will be used for the production of the Dado #5-21 well.
