Twenty-six total groundwater samples were collected and analyzed for TPH-DRO, TPH-GRO, BTEX, and Naphthalene by EPA Methods 8015 and 8260b. Once soil sample (SS01@3') was also analyzed for SAR, pH, and EC by USEPA Method 6020 / United States Department of Agriculture (USDA) Method 60 6(2,3A), EPA 9045D, and EPA 120.1.
