2. RU wireline company.
3. TIH with CIBP. Set BP at 6506'. Top with 2 sxs 15.8#/gal CI G cement.
4. TIH with tubing to 1700'. RU cementing company. Mix and pump 40 sxs 15.8#/gal CI G cement down tubing. (Pierre coverage from 1700'-1200').
5. TIH with casing cutter. Cut 4 1/2" casing at 787. Pull cut casing.
6. TIH with tubing to 837'. Mix and pump 420 sxs 15.8#/gal CL G cement down tubing. Cement should circulate to surface.
7. Cut surface casing 6' below ground level and weld on cap.
