Five discreet confirmation soil samples were collected on 11/12/18 (4 wall and 1 base) from the produced water tank excavation and analyzed for benzene, toluene, ethylbenzene, total xylenes (BTEX), gasoline range organics (GRO), and diesel range organics (DRO). Concentrations of BTEX, GRO, and DRO were either not detected at or above laboratory reporting limits or were reported below their respective COGCC Table 910-1 concentration levels. See the attached laboratory report, soil analytical table, and Figure 3.
