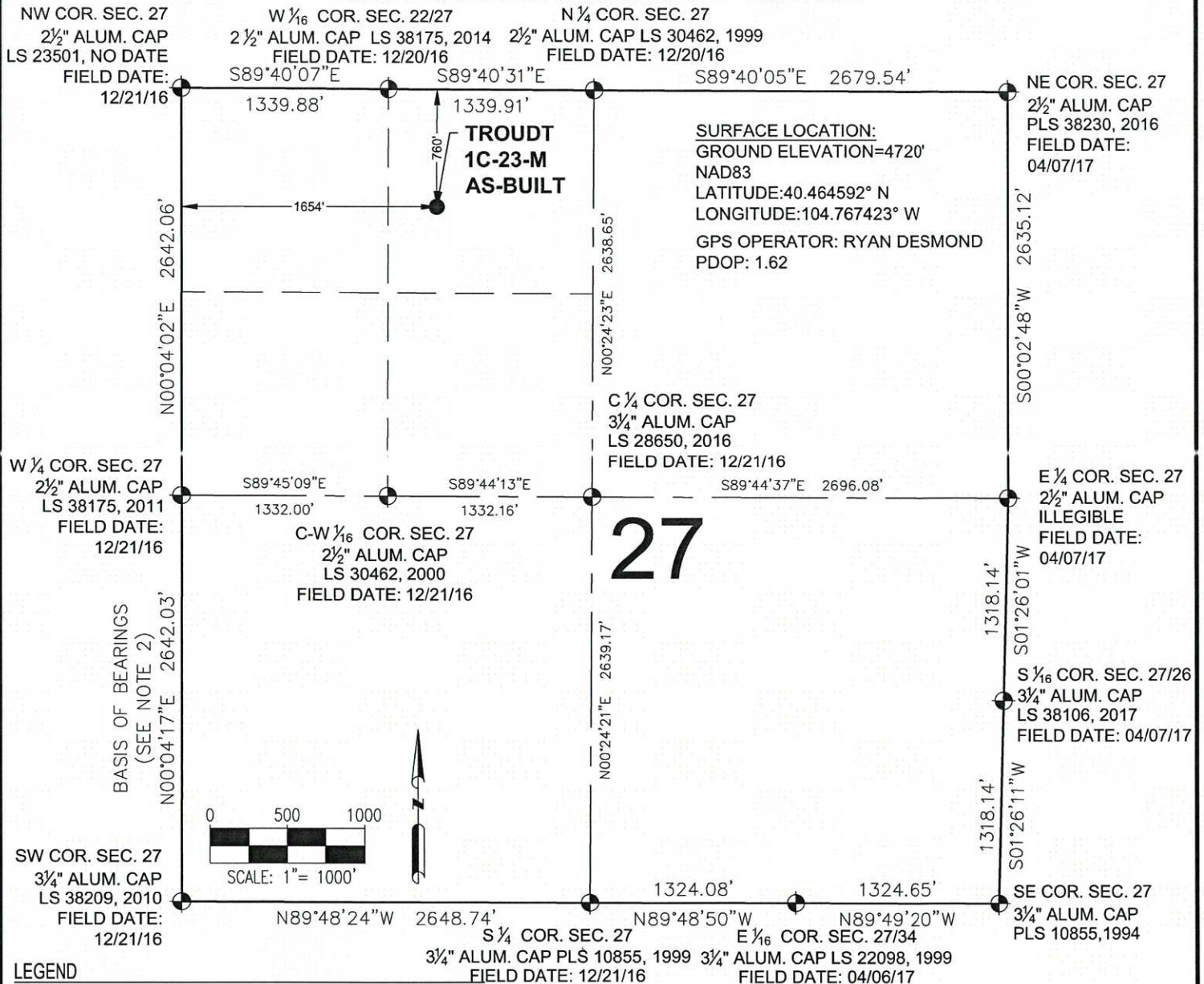


TROUDT 1C-23-M WELL LOCATION CERTIFICATE - AS-BUILT

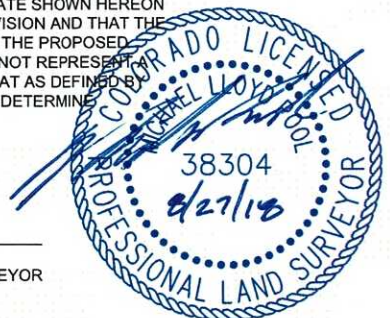


WELL TROUDT 1C-23-M LOCATED 760' FNL & 1654' FWL
