**COMMENTS:**

On 9/21/2018 a CIBP was set @ 6485' with 2 sxs cmt, a 2nd CIBP was swt @ 6450' with 25 sxs cmt. A Form 5A to report AB status of Codell and JSand formations was submitted on 11/20/2018 (Doc # 401843273); This well is a safety shut-in for an offset frac prep for the Wetco Farms A-4 Pad (Location ID: 431774). The well is closed to the atmosphere via valve and the "Temporary SI for HZ Prep" sign is attached to the master valve. We are requesting continued TA status until the well can be fully plugged and abandoned. A Form 6 NOI has been submitted and approved (Doc # 401668187) and is scheduled to be P&A'd by 1/26/19. Well pressure tested 500-700#, held pressure for 15 minutes, test was good. Recorded results are attached.
