Comment: **This location does not meet reclamation requirements or in accordance with COGCC reclamation rule. Rule 1004.a requires compaction alleviation to be conducted by crossripping to a depth of 18 inches. Location has not been cross-ripped. Unable to find evidence that compaction alleviation has been conducted on access road. Compaction concerns remain evident on both location and access road.**

Corrective Action:	Comply with 1004 and perform reclamation. At a minimum, compaction alleviation will need to be conducted at the well location and access road by cross ripping to a minimum depth of eighteen (18) inches. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities. Records show well PA 04/07/2017. 1004.a requires all reclamation activities to be completed within three (3) months on cropland after plugging well. A CA date of 7/7/2017 is being provided as this is when reclamation activities should have been conducted by.	Date	07/07/2017
