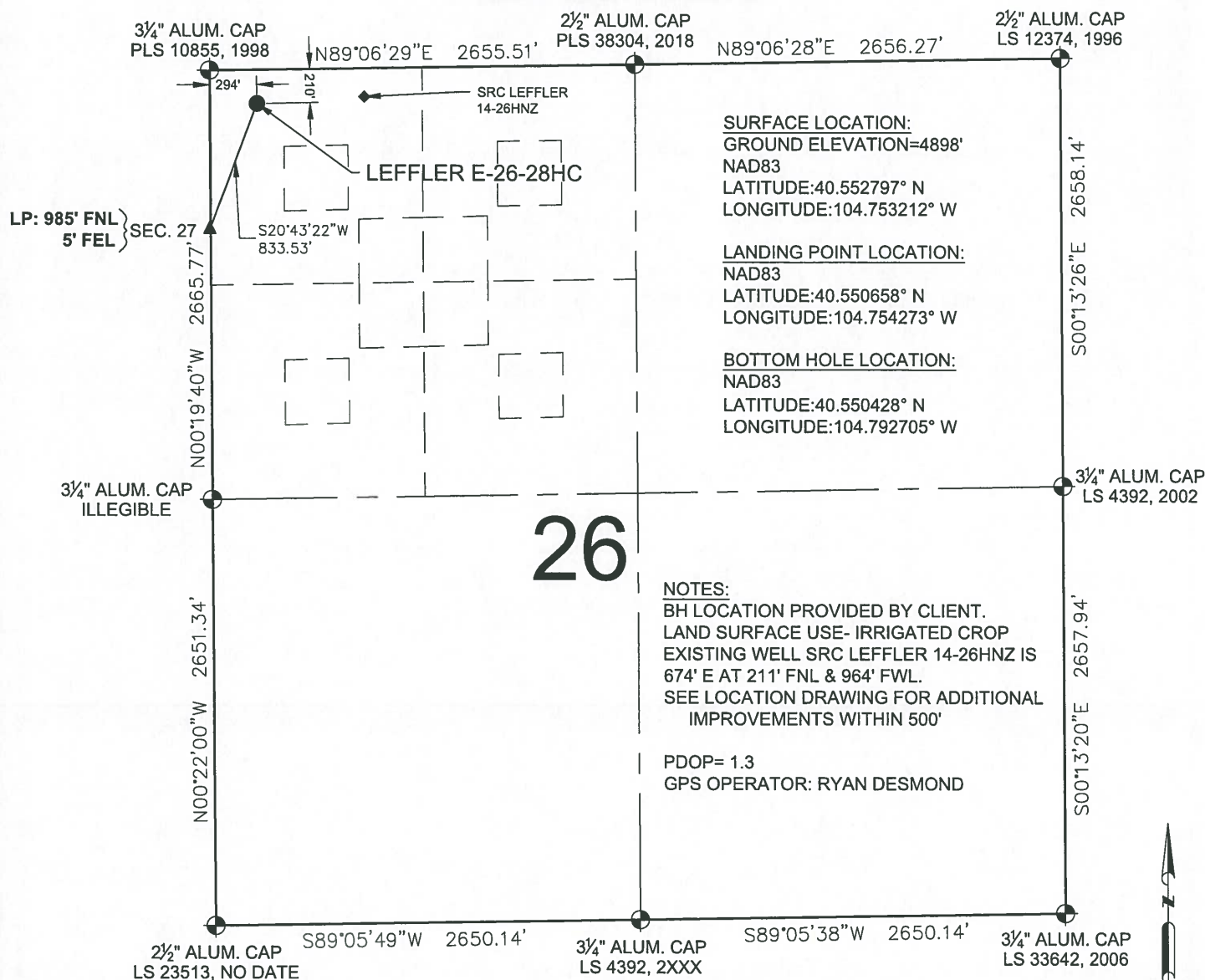


LEFFLER E-26-28HC WELL LOCATION EXHIBIT

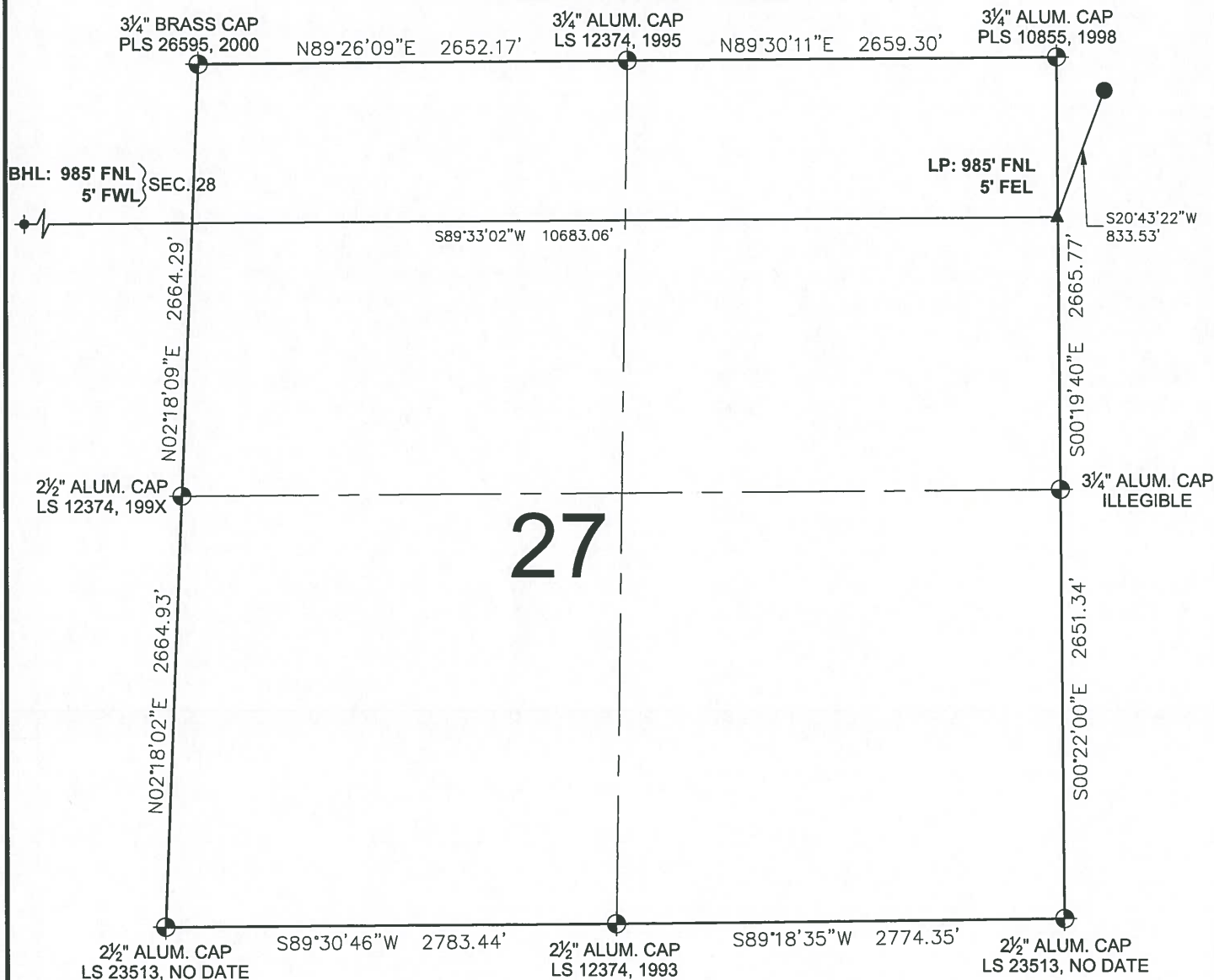

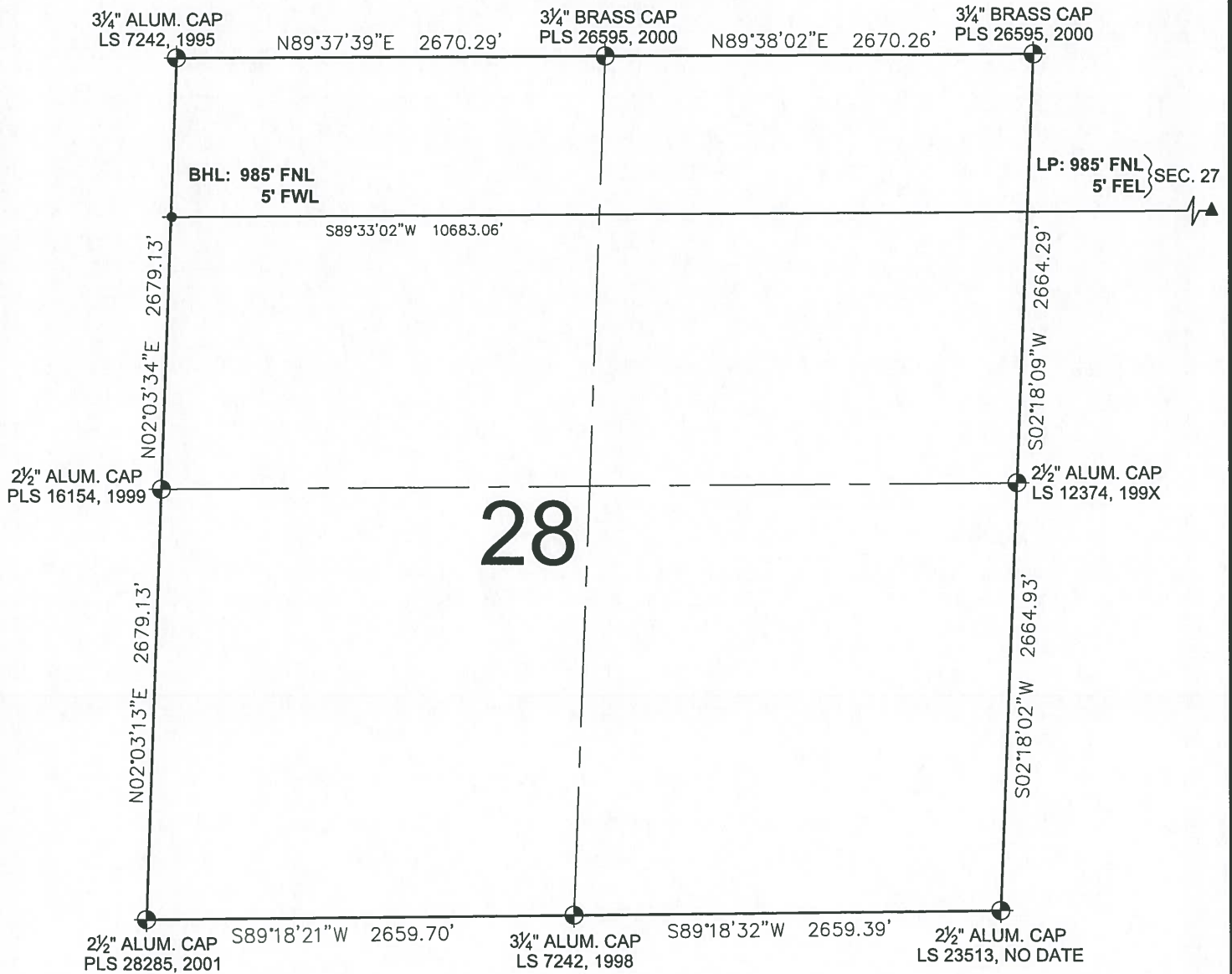
