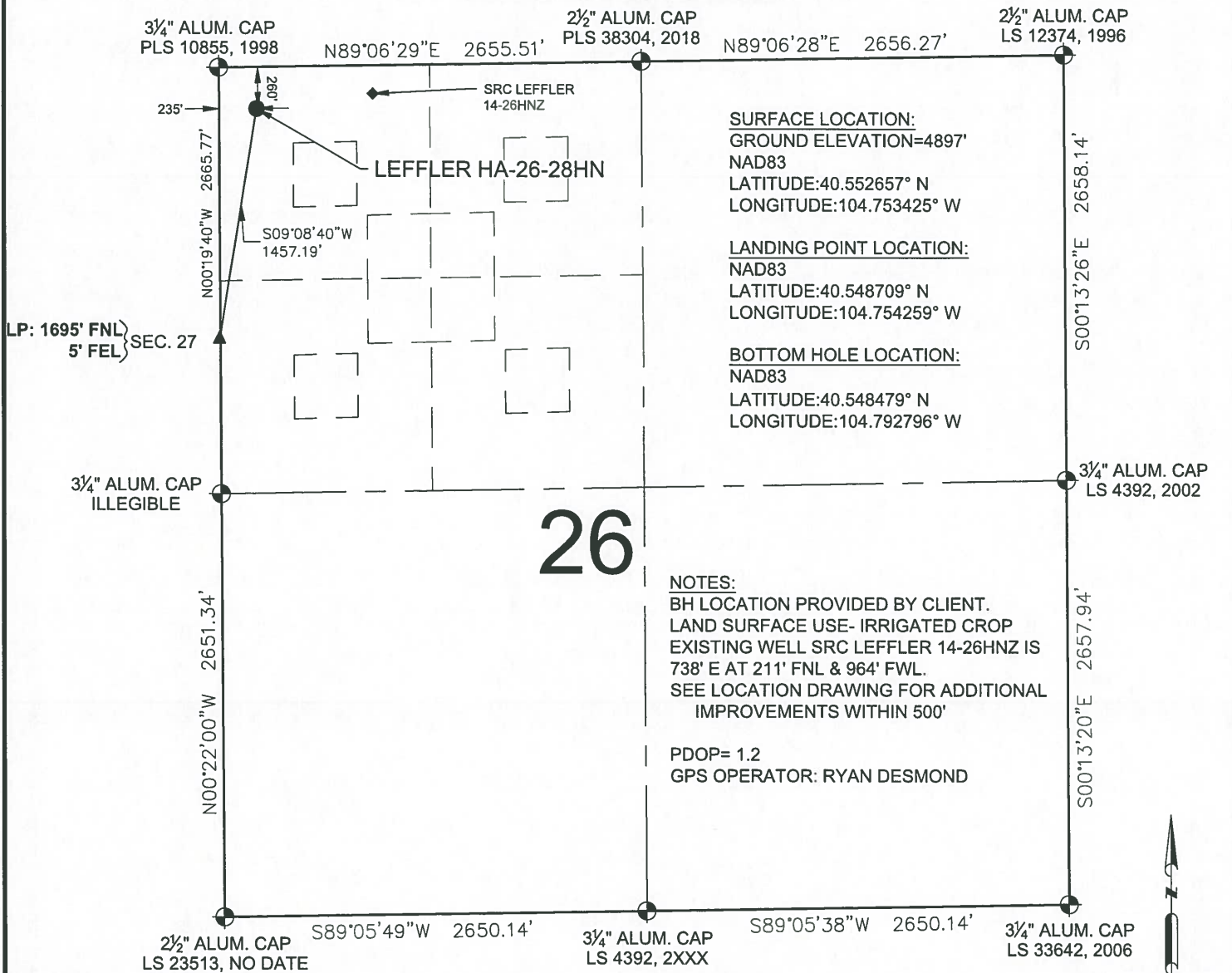


LEFFLER HA-26-28HN WELL LOCATION EXHIBIT

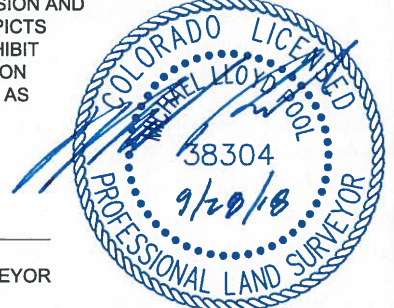
NOTES:
