On 7/22/2017 a RBP was set @ 6630' for offset mitigation/well safety prep with a 5K wellhead closing well to the atmosphere. This well was TA for safety prep for the fracting of PDC's Stella Pad, Location #323460. Due to on-going rig visits and fracs in the area, this well will remain TA until all activity in the area is completed within the next 2 years. If the well is still TA at the 2 year point, a MIT will be performed.
