Tuesday Sept 18 2018 excavated area back filled, and excavated material (Non E&P Waste) moved from wellhead site to adjacent Peakview owned surface land. Through olfactory/sniff testing and taste testing, water was determined to be fresh. Algae was growing in the fresh water seepage.
