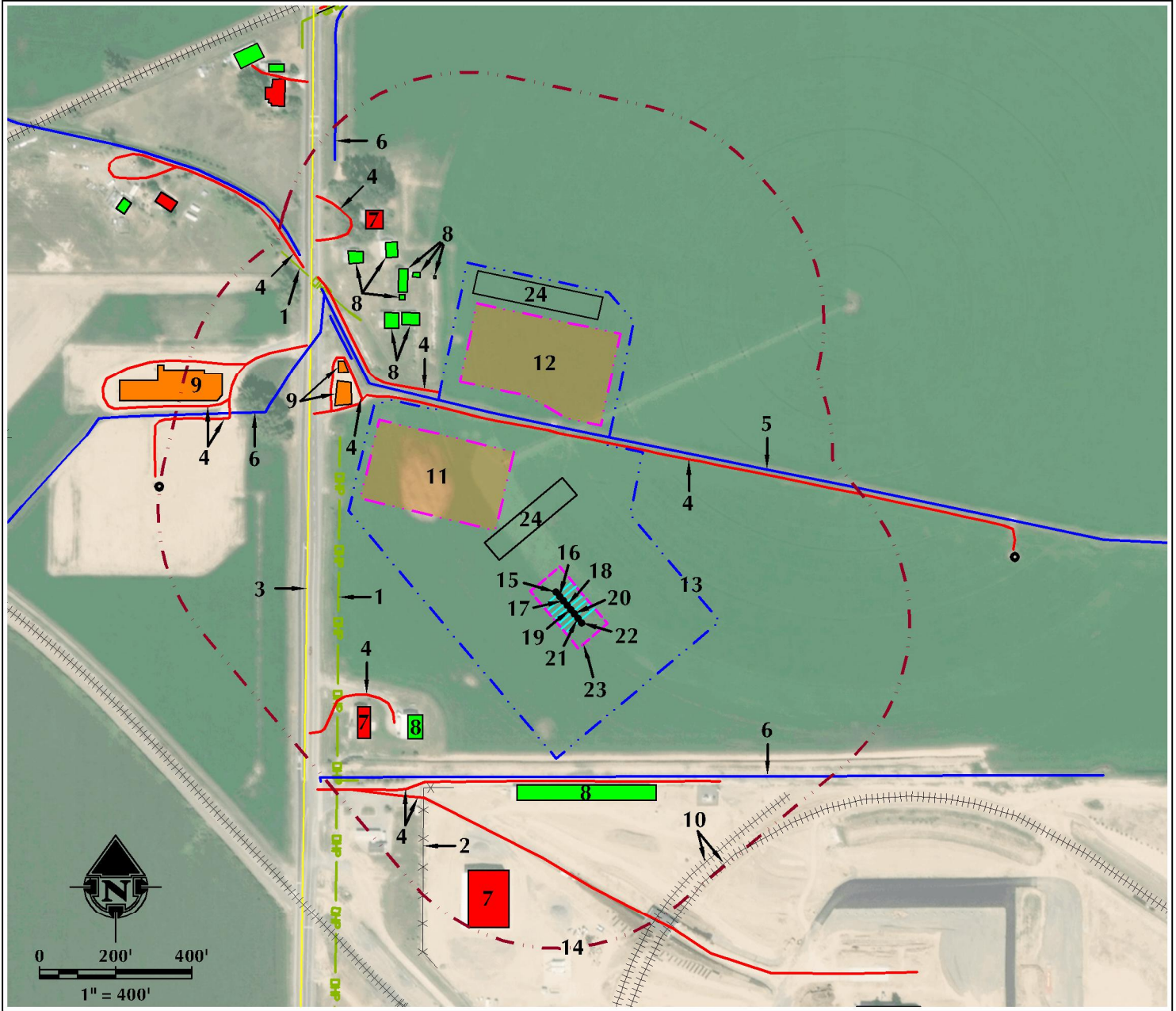


LOCATION DRAWING DAMORE 5-18HZ HORIZONTAL MULTI-WELL PAD
