Surficial soil samples will be collected from within the produced water pit at approximately 45-foot centers. A soil boring will be advanced at one of the aforementioned surficial soil sample locations. An additional soil sample will be collected from the soil boring once native soil is encountered. The soil samples will be submitted for BTEX, DRO, GRO, ORO, EC, and pH analysis. If EC exceeds Table 910-1 standards, SAR will also be analyzed. The proposed soil sample locations are depicted on the attached Figure 1. A background soil sample will be collected from an undisturbed location off the pad.
