Without Variance Request Approved or In Process, Location Fails Final Reclamation.

Equipment and Facilities have been removed except for one set of flowline/pipeline risers (Photo#3 attached). Surface Owner has constructed a barn where the pad was previously located. Berm and sound wall remain on North end of site. Areas of Location South & West of Barn have not been recontoured and appear compacted and graveled. Row of evergreen trees is established on West Perimeter (Wind or Visual barrier). Surface Owner is utilizing portions of pad as Stodge area. Noxious B list weed, Scotch thistle is established on site. Refer to Photo Log attached.

Corrective Action:

There are three (3) CAs in this Section.

CA#1: Comply with Reclamation rules to remove unknown Riser#1 (regardless of ownership) by 12/31/18 or provide documentation if Riser is identified as completely unrelated to Well & Location.

CA#2: Submit 502b Variance request by 1/28/19 or; Perform Final Reclamation of Location per COGCC 1004 Rules; Reclamation Activities to be complete by June 1, 2019.

CA#3: Control Noxious weeds, developing a weed control program for site, commencing controls by 5/15/19.
