Perform reclamation in accordance to COGCC 1000 series rules on the access road, including by not limited to, removing gravel, compaction alleviation, regrading/recontouring and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 3/31/2018.

Operator Comment: Operator has conducted reclamation activities on the access road, approximately 1200', leading from the east west road to the pre-existing Sohio pad and has conducted additional reclamation activities on the road between the Sohio pad to the Craig pad.
