Good morning Eric,

Thank for the call this morning. **The fresh water pond adjacent to the RWF 14-29 pad on Mr. Duggan's property is his fresh water irrigation pond. That pond is not associated with our operations on the RWF 14-29. The 12" steel pipeline that goes from the pond down to the river is also Mr. Duggan's. During the irrigation season, Mr. Duggan pumps out of the river through that 12" steel pipe into that pond. The water in the pond then goes into his irrigation system in his field.**
