Crestone was stimulating the Melbon Ranch 4H-, 4I-, 4J-, 4K-17H-M265 wells (zipper) when the Melbon Ranch 4D-17H-M265 bradenhead pressure increased and exceeded the 200psi pressure change threshold. Crestone alerted the COGCC via email on 12/5/18 including status and pressures on the other wells. Crestone blew the well down to 0psi. There was no fluid. Crestone will continue to monitor during the fracs and blow the well down before it reaches the 200psi threshold.
