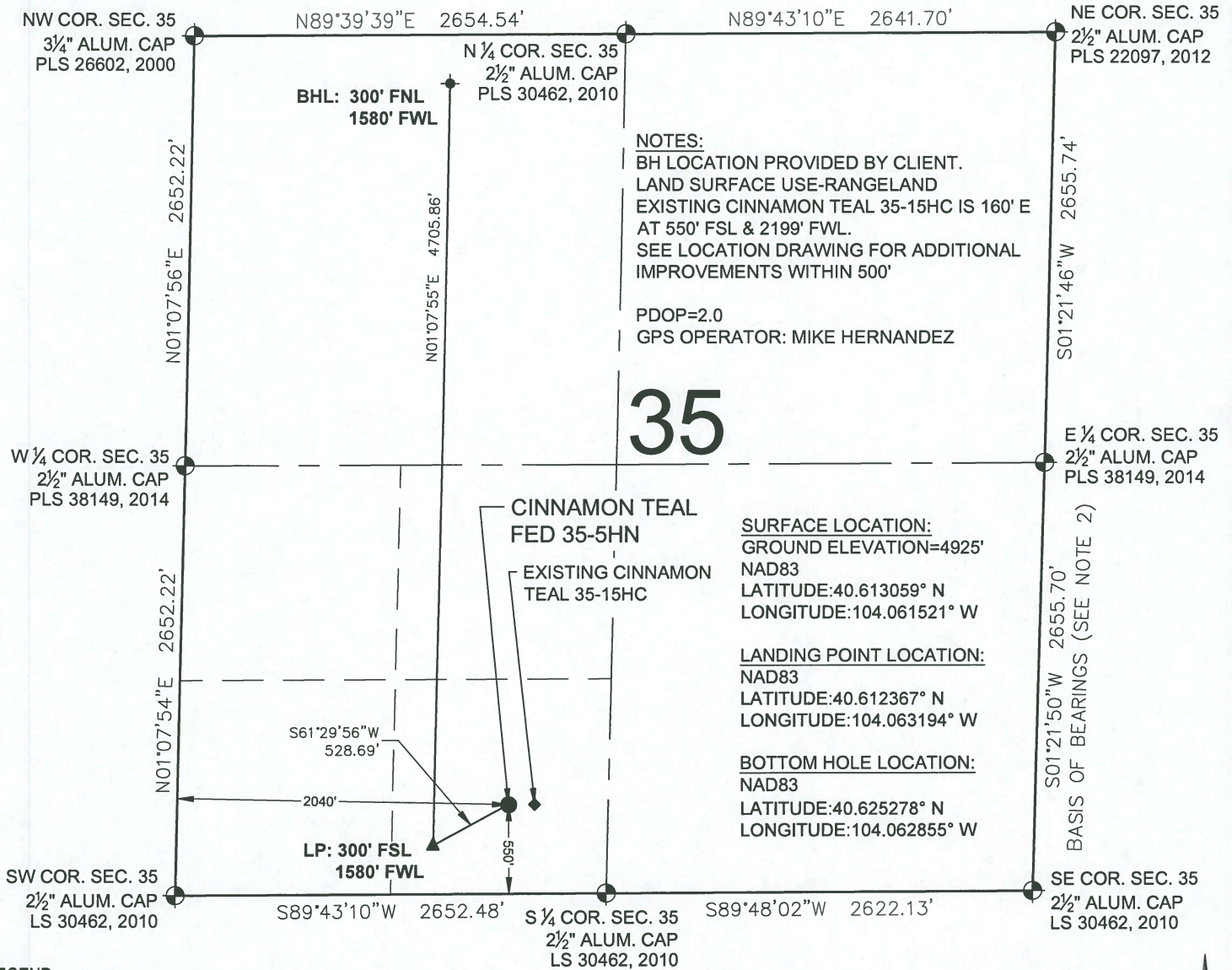


CINNAMON TEAL FED 35-5HN WELL LOCATION CERTIFICATE
