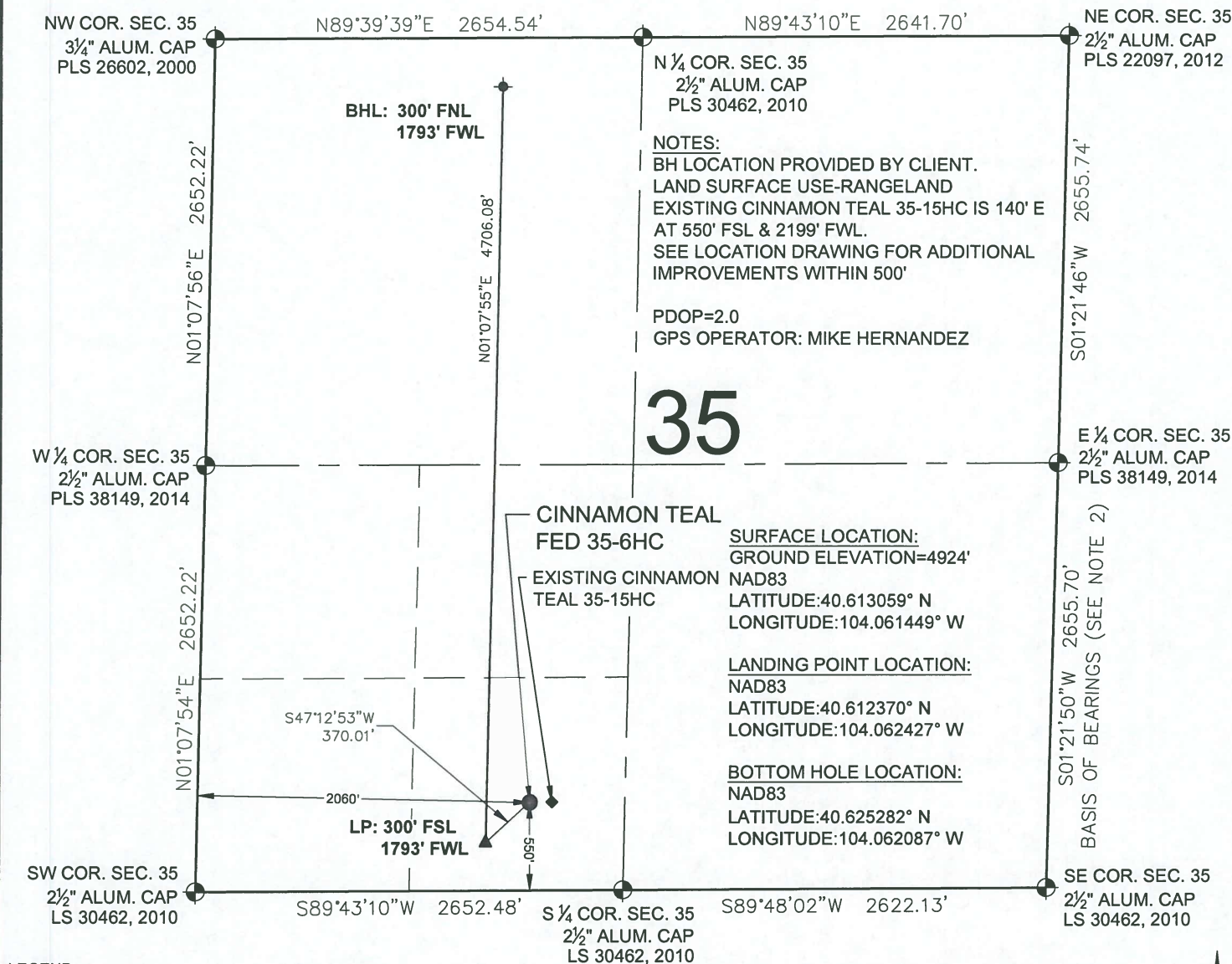


CINNAMON TEAL FED 35-6HC WELL LOCATION CERTIFICATE
