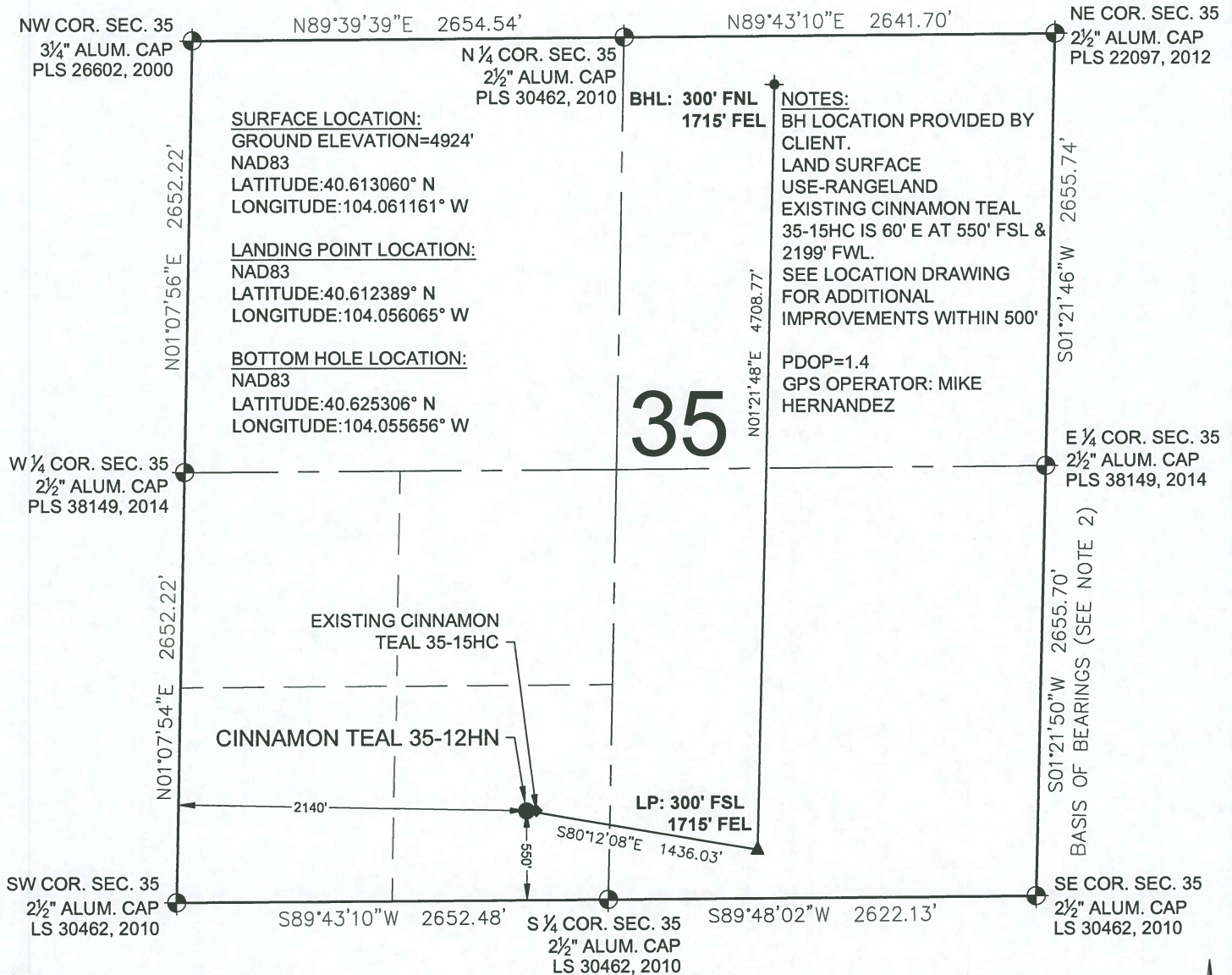


CINNAMON TEAL 35-12HN WELL LOCATION CERTIFICATE
