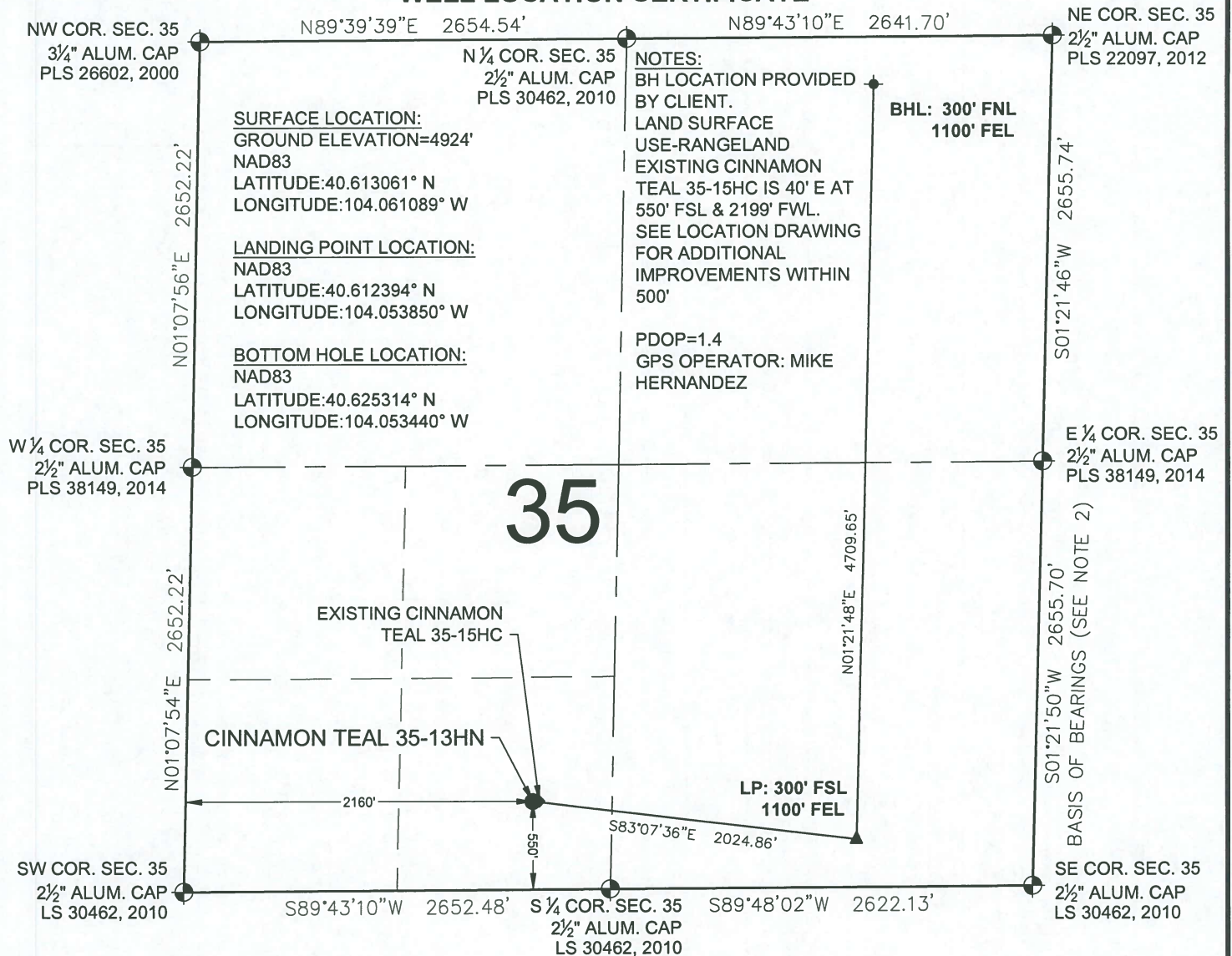


CINNAMON TEAL 35-13HN WELL LOCATION CERTIFICATE
